

What is R2? What is RIOS?

The principles of R2 & RIOS are similar in nature.

R2 Responsible Recycling is a set of voluntary principles and guidelines designed to promote and assess responsible practices for electronics recyclers. R2 requires that companies be held accountable for their practices and downstream management, both nationally and internationally.

RIOS, or Recycling Industry Operating Standard, integrates Quality, Environmental, and Health & Safety Management systems components into one. Created by the Institute of Scrap Recycling Industries (ISRI), the standard is specifically designed for the scrap recycling industry, to promote successful Quality, Environmental, Health & Safety Management system performance.

In October 2008, the ISRI Service Corporation (ISC), which administers the RIOS program, agreed to support R2 certification through RIOS implementation. As a result, recyclers can greatly benefit from the partnered integration of R2 and RIOS.

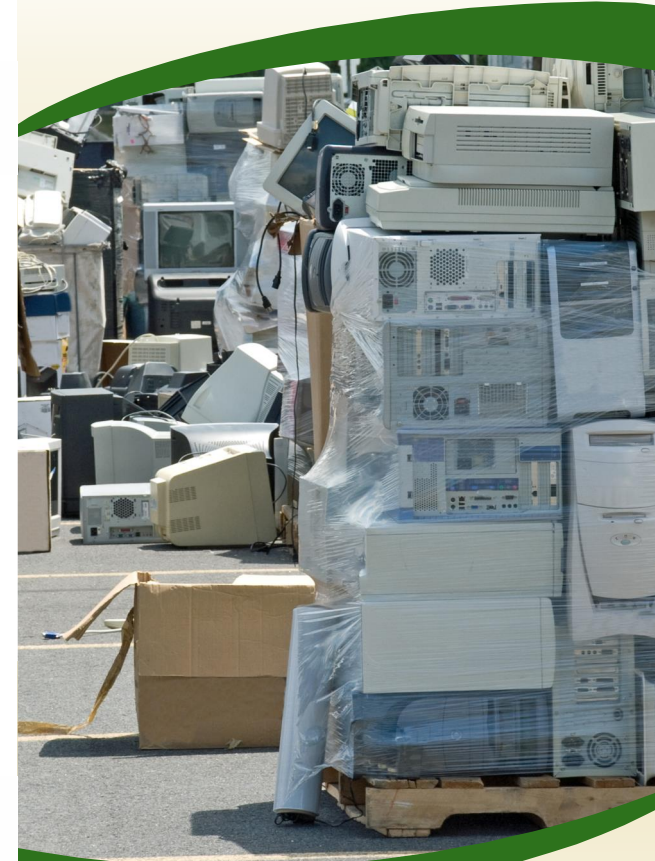
