PJR'S CERTIFICATION PROGRAMS



ISO 9001

ISO 9001 is the internationally recognized global standard for **Quality Management Systems (QMS)**. It confirms an organization's commitment to improving quality, delivering more efficient operations, and improving customer satisfaction.



IATF 16949

IATF 16949 is the international standard for **Automotive Quality Management Systems**. It demonstrates an organization's commitment to delivering high-quality products and services to the automotive industry.



ISO 26262

ISO 26262 is the international standard for **Functional Safety** in the automotive industry. It provides a framework for ensuring the safety of electrical and electronic systems in vehicles.



ISO 39001

ISO 39001 is the international standard for **Road Traffic Safety Management Systems**. It provides a framework for organizations to improve road safety and reduce the risk of accidents.



FSSC 22000

FSSC 22000 is a GFSI-recognized program. Certification to FSSC allows manufacturers to focus their food safety efforts on scientific and technical advances, and their audit resources on improvement rather than compliance.



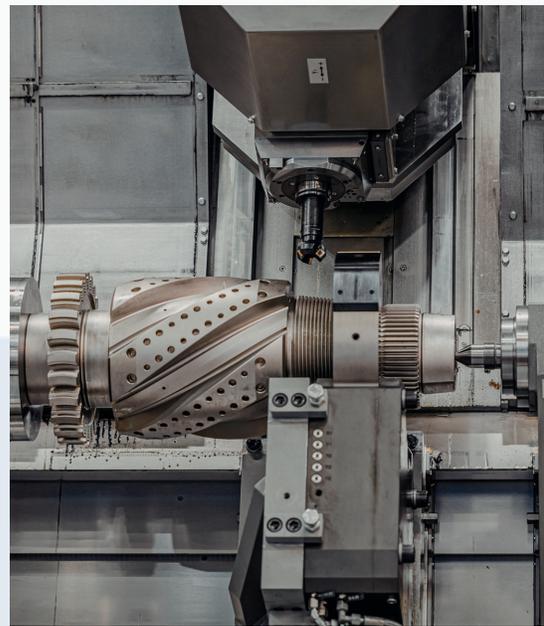
ISO 22000

A food safety standard applicable to all types of producers throughout the global food supply chain, ISO 22000 offers guidelines for what organizations must do to demonstrate their ability to control food safety hazards.



AS9110

Similar to AS9100, AS9110 is a quality management system for the aerospace industry. However, AS9110 stands apart as being intended for aerospace maintenance, repair, and overhaul organizations (MROs).



AS9120

A sector-specific certification for aerospace suppliers known as “stockist distributors” or “pass-through distributors.” This standard was intended to replace the old SAE standard AS7103. Unlike AS9100, AS9120 does not contain ISO 9001 in its entirety.

AS9100

The ubiquitous **aerospace industry standard**, AS9100 incorporates ISO 9001 elements with unique aerospace aspects. Developed by a committee of executives from the major US aerospace manufacturers, AS9100 is intended to reduce supplier chain defects, improve quality, increase customer satisfaction, and reduce the amount of time spent on audits, requirements, and documentation.





ISO 14001

ISO 14001 is the internationally recognized global standard for **Environmental Management Systems (EMS)**. It confirms an organization's commitment to improving environmental performance, reducing waste, and enhancing sustainability.



ISO 45001

ISO 45001 is the internationally recognized global standard for **Occupational Health and Safety Management Systems (OHSMS)**. It confirms an organization's commitment to improving employee safety, reducing workplace risks, and creating safer working conditions.



R2v3

R2 is the leading certification standard for **Responsible Recycling** practices. It ensures that certified organizations adhere to the highest standards of environmental responsibility and sustainability.



RIOS

Recycling Industry Operating Standard (RIOS) is an integrated management system standard designed specifically for the recycling industry, combining quality, environmental, and health and safety requirements into a single framework.



e-Stewards

e-Stewards is a program that ensures responsible **reuse and recycling of electronic waste**. It establishes environmental, health, safety, and data security requirements to prevent hazardous e-waste from being improperly handled or exported.



ISO 50001

ISO 50001 is the international standard for **Energy Management Systems (EnMS)**. It provides a framework for organizations to manage energy efficiently, reduce costs, and improve sustainability.



ISO/IEC 42001

ISO/IEC 42001 is the internationally recognized global standard for **Artificial Intelligence Management Systems (AIMS)**. It provides a framework for organizations to manage and mitigate risks associated with AI technologies.



ISO 22301

ISO 22301 is the internationally recognized global standard for **Business Continuity Management Systems (BCMS)**. It provides a framework for organizations to prepare for, respond to, and recover from disruptive incidents.

ISO/IEC 27001

The international standard for **Information Security Management Systems (ISMS)**, ISO/IEC 27001 provides a model for risk assessment, security design/implementation, and security management. This standard demonstrates the steps organizations have taken to protect sensitive information against unauthorized access.

TL 9000

TL 9000 is the telecommunications industry's quality management standard. It provides a framework for organizations to improve their processes and deliver high-quality products and services.

BA 9000

The standard for **Body Armor Management Systems**. It establishes organizational processes, product traceability, material control, testing, and continual improvement to ensure quality, performance, and compliance.

ISO 37001

ISO 37001 is the international standard for **Anti-bribery Management Systems**. It provides a framework for organizations to prevent, detect, and respond to bribery.

ISO 20000

ISO 20000 is the international standard for **IT Service Management (ITSM)**. It provides a framework for organizations to deliver managed services of an acceptable quality for their customers.

PAS 24000

PAS 24000 is an internationally recognized specification that provides requirements for establishing, implementing, maintaining, and improving a social management system.

ISO 13485

ISO 13485 is an internationally recognized quality management system standard specifically for medical device manufacturers and related organizations. It outlines requirements to ensure consistent design, production, and delivery of safe and effective medical devices.

ISO 22716

The ISO 22716 standard provides guidelines for Good Manufacturing Practices specifically for the cosmetics industry. It covers production, control, storage and shipment. Ensuring product safety and quality while facilitating regulatory compliance.
