What's changed?

At a very high level the changes include 56 controls being merged into 24 newly titled controls and 11 completely new controls.

All controls have now been placed in 4 themed sections instead of the 14 control groups from the old standard; these are:



Organisational



People



Physical



Technological

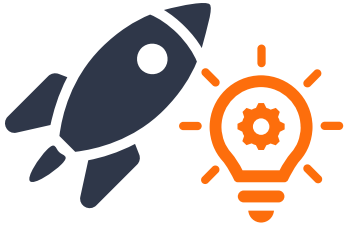


Raising Awareness
